

NOTICE OF UTILITY TARIFF FILING

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that GOLDEN VALLEY ELECTRIC ASSOCIATION, INC. (GVEA), an electric utility, has filed a tariff revision (TA128-13) which includes a revenue requirement, cost of service and rate design study. As a result of these studies, GVEA proposes the following rates:

GVEA also proposes to reduce the base fuel and purchased power rate used in its Cost of Power Adjustment calculation from \$0.0496/kWh to \$0.04127/kWh. Fuel and purchased power costs over this base amount will be recovered through the fuel surcharge; if actual fuel and purchased power costs are below this base amount, the customer will receive a credit through the fuel surcharge.

The impact of the proposed rate changes on both a residential and small commercial bill of 750 kWh is shown in the table below.
